Curriculum Register November 18, 2019

This publication contains proposed curriculum changes. This Curriculum Register conforms to the curriculum review process as described in the fall 2007 Curriculum Review Guide. It contains two sections, **Campus-wide Proposal Sharing**, which includes a synopsis of course and program proposals that have been submitted for review to their department curriculum committee or program faculty and **University Curriculum Committee (UCC) Recommendations** that includes completed information on proposals reviewed by UCC.

Every proposal must complete all stages of the curriculum review process:

- 1. Submission of proposal(s) by originating department/program.
- 2. Review by Department Curriculum Committee or Program Faculty.
- 3. Campus-wide Proposal Sharing in the Curriculum Register.
- 4. Review by the Dean for school/college resource implication; preparation of resource impact statement.
- 5. Review by the originating College Curriculum Committee.
- 6. Review by General Education or Graduate Council, when appropriate; preparation of impact statement
- 7. Review by the University Curriculum Committee (UCC).
- 8. Review by Academic Affairs Program Effectiveness Committee, when appropriate.
- 9. Approval by Vice President for Academic Affairs or designee.
- 10. Approval by President, when appropriate.
- 11. Approval by Off Campus Approval bodies, when appropriate.

Moratorium for Proposals in Campus-wide Sharing Stage:

There will be a 10 working-day moratorium, starting from the publication date of the Curriculum Register, during which departments, deans, or individual faculty may raise objections or concerns, in writing, to the proposing School or College Curriculum Committee or Program Faculty for proposals in the campus-wide sharing stage. The Campus-wide Sharing section of the Curriculum Register contains only a summary of the curriculum proposal. Please ask the Department Curriculum Committee or Program Faculty for a complete proposal packet if you have questions or concerns.

Moratorium Date: December 3, 2019

Once the moratorium date has passed for campus-wide sharing and no objections are received, the proposal will continue through the stages of the curriculum review process.

Summary of changes: Course Title change to "Introduction to Chicano/a Literature." Special attention given to certain issues of Chicano/a experiences reflected in the literature. Frequent written assignments." The course description modification replaces "Chicano" with "Chicana/o" and replaces "the Chicano experience" to "Chicano/a experiences." The title and course description changes are in keeping with the field and provide a more accurate reflection of what the course covers, as it includes the writings of Chicanas and Chicanos of various gender identifications and communities.

Summary of changes: Title change to "Introduction to Comparative Ethnic Studies" to be more

student friendly while still reflecting the course content.

Summary of changes: Title and course description changes. Title change to "Latina/o Perspectives on U.S. Immigration and Citizenship" and description change to "Seeks to understand some of the issues which concern Latino/a immigrants, specifically Mexican and Central American groups, in efforts to bring awareness to this human crisis and to explore some of its effects on U.S. Latina/o communities." These changes provide both clarity and inclusivity. We add the "-a/o" to be gender inclusive and change "perspective" to "perspectives" to acknowledge the diversity of perspectives and experiences in Latina/o communities. We believe this would more accurately describe the course.

Summary of changes: Course title and description changes. The historical experiences of these diverse communities will be examined." These changes provide both clarity and inclusivity regarding the course content.

Summary of changes: Title change to "Native American and Chicana Women's Narratives." We find the term "prose" to be misleading, as it implies that only a certain form of written expression. We propose the slight change to "narratives" to more accurately reflect the course.

Summary of changes: Chicana/o Studies is proposing CHS 372: Chicana/o Spiritualities and Healing Practices as a new course to be added to Cultural and Historical Inquiry (CHI) elective area for CHS majors, and as an elective option for CHS minors. Within Chicana/o Studies, research on spiritualties and healing practices is a growing field and this course will provide students the opportunity to engage in this emerging area of learning and scholarship.

College of Health, Human Services, & Nursing

Program/Course: RN-BS Nursing **Type of Change:** Program Modification

Proposer: Nop

Summary of Changes: The Chancellor's Executive Order 1084 (issued on January 10th, 2013) indicates that any CSU campus may award academic credits using the NCLEX (National Council Licensure Examination for obtaining an RN license) to demonstrate prior learning of the pre-licensure art and science of nursing required by the Board of Registered Nursing. Per title 5 section 40408, if a student has passed the NCLEX examination, a CSU campus may apply toward the BSN degree one unit of academic credit for every unit of the required pre-licensure community college nursing course credits that were not transferred to the CSU baccalaureate program, with a maximum of 30 semester units (45 quarter units) to be awarded through the NCLEX provision. The awarding of NCLEX credit shall be accomplished without requiring students to enroll in FTES-generating courses and without charging students a fee for the units awarded.

For RN-BSN program admission, the maximum of 70 units can be transferred from a community college (e.g., 40 units of pre-requisite and GE requirements plus 30 nursing units). The cumulative total for an ADN graduate to obtain a BSN degree is 120 units. RN-BSN students then need to complete 50 units at CSUDH. As of now, BSN students are given 6 units for NCLEX (since the BRN requires 36 nursing units for the RN license [1] and only up to 30 nursing units can be transferred in). Once admitted, the students complete 44 units to earn the BSN degree;

- > 35 units of BSN courses
- ➤ BSN 306 (3units) and BSN 346 (3 units) are double-counted
- > 3 units of the upper GE course (HUM 310)

However, our RN-BSN program enrollment has significantly decreased from approximately 600 students (in Fall 2016 when the 6 NCLEX units were first given) to 250 students in Fall 2019. The SON has identified various factors impacting the enrollment. One major concern is that our curriculum is not competitive enough for licensed RNs who want to earn their BSN as soon as possible (while the other two RN-BSN programs at the neighbor CSU campuses are giving 20-21 units for NCLEX credits). Furthermore, we want to optimize the prior learning credit since our feeder programs often require students to take more than 36 nursing units (e.g., ECC curriculum contains 45.5 nursing units).

In order to be competitive and boost the graduation rate, we are proposing to revise the RN-BSN Program Curriculum based on "Go Lean" concept while ensuring that our curriculum meets-

- 1. The Institution Student Learning Outcomes (ISOs) and Program Learning Outcomes (PLOs).
- 2. The Commission on Collegiate Nursing Education accreditation standards, so called the "Essentials" [2]

The major changes taking place in this revision:

- 1. We will give up to 24 units for NCLEX credit.
- 2. We no longer require the RN-BSN students to complete some courses which the basic content has been required in their Associate Degree in Nursing (ADN) program, governed by the Board of Registered Nursing [1]. These courses are BSN 307,340, 400, and 408. In addition, any essential content from these courses is threaded in various courses throughout the revised curriculum.
- 3. We decreased the number of units of BSN 380 Health Assessment from 3 to 2 units (and gave a new course number as BSN 382). The course description and course objectives remain the same. But, we decreased the reading and discussion assignments and ensure that the remaining main assignments meet the course objectives, PLOs, and the Essentials.
- 4. We created a new course (BSN 452) by combining BSN 430 (Health Care Systems, Policy, and Finances) and BSN 450 (Leadership and Management) while maintaining the core content of both areas.
- 5. We no longer require BSN 451 (Leadership and Management Role Performance). Students will complete various leadership and management assignments in BSN 452 course which still meet the PLOs and the Essentials.

- 1. Students who are awarded less than 24 units may complete any upper division, online courses on campus including BSN 494 in order to obtain the 120 unit-requirement.
- 2. BSN 307, 340, 400, 408 will be frozen. BSN 380, 430,450, and 451 will be discontinued.
