## Curriculum Register September 18, 2017

This publication contains proposed curriculum changes. This Curriculum Register conforms to the curriculum review process as described in the fall 2007 Curriculum Review Guide. 3. Review by Department Curriculum Committee or Program Faculty.
4. Campuswide Proposal Sharing in the Curriculum Register.
5. Review by General Studies, Liberal Studies, or Graduate Council, when appropriate; preparation of impact statement.
6. Review by the Dean for school/college resource implication; preparation of resource impact statement.
7. Review by the Office of Academic Programs; preparation of university resource impact statement.
8. Review by the originating School/College Curriculum Committee.
9. Review by the University Curriculum Committee (UCC).
10. UCC recommendations posted in the Curriculum Register.
11. Review by Academic Affairs Program Effectiveness Committee, when appropriate.
12. Approval by Vice President for Academic Affairs or designee.
13. Approval by President, when appropriate.
14. Approval by Off Campus Approval bodies, when appropriate.

## Moratorium for Proposals in Campuswide Sharing Stage:

There will be a 10 working day moratorium, starting from the publication date of the Curriculum Register, during which departments, deans, or individual faculty may raise objections or concerns, in writing, to the proposing School or College Curriculum Committee or Program Faculty for proposals in the campuswide sharing stage. The Campuswide Sharing section of the Curriculum Register contains only a summary of the curriculum proposal. Please ask the Department Curriculum Committee or Program Faculty for a complete proposal packet if you have questions or concerns.

## Moratorium Date: September 29, 2017

Once the moratorium date has passed for campuswide sharing and no objections are received, the proposal will continue through the stages of the curriculum review process.

The program also provides students with a deeper understanding of health system and hospital operations and the critical need for inter-professional teaming in today's evidence-based healthcare delivery models.<br>A strong core of faculty with significant academic and industry experience combined with practice-based instruction insures the connection between academic principles and current healthcare practice. In addition, students participate in a personal leadership and coaching program which includes communications and mock presentations and interviews.

## Program/Course: Master of Science in Nursing: Clinical Nurse Leader (MEPN) Proposer: Rose Welch <br> Type of Change: Program Discontinuance <br> Summary of Changes: The School of Nursing (SON) faculty voted to suspend admissions into the Clinical Nurse Leader role option in the Masters of Science of Nursing (MSN) program. This program, also known as the Masters Entry Professional Nursing (MEPN) program was a program whereby individuals with prior non-nursing Bachelor's degrees could pursue the nursing field at the graduate level. The curriculum consisted of the pre-licensure nursing content required by the Board of Registered Nursing, in addition to graduate level coursework required for the graduate degree. The role focus for these students was Clinical Nurse Leader. The primary reason for the suspension and closure of the program was the program's inability to achieve and maintain the minimum pass rates on the NCLEX-RN (national licensing examination) as required by the California Board of Registered Nursing (BEN) and American Association of College of Nursing (AACN).

The BRN and AACN required the SON to address the sub-optimal NCLEX pass rates and develop an action plan to address the deficits. While the plan was submitted to these bodies and implemented, and the program was still approved by the BRN, the SON faculty decided to suspend admissions, and subsequently, close the program. Closure of the program does not affect other departments at CSUDH.

Plans for accommodating students affected by the discontinuance
The last cohort of students in this option graduated in August 2015. Since admissions have been suspended since that time, there are currently no students enrolled. Therefore, there are no students that need to be accommodated.
