## Curriculum Register November 20, 2017

This publication contains proposed curriculum changes. This Curriculum Register conforms to the curriculum review process as described in the fall 2007 Curriculum Review Guide. It contains two sections, Campuswide Proposal Sharing, which includes a synopsis of course and program proposals that have been submitted for review to their department curriculum committee or program faculty and University Curriculum Committee (UCC) Recommendations that includes completed information on proposals reviewed by UCC.
Every proposal must complete all stages of the curriculum review process:

1. Submission of proposal(s) by originating department/program.
2. Review by every department/program in the school/college in which the program is housed.
3. Review by Department Curriculum Committee or Program Faculty.
4. Campuswide Proposal Sharing in the Curriculum Register.
5. Review by General Studies, Liberal Studies, or Graduate Council, when appropriate; preparation of impact statement.
6. Review by the Dean for school/college resource implication; preparation of resource impact statement.
7. Review by the Office of Academic Programs; preparation of university resource impact statement.
8. Review by the originating School/College Curriculum Committee.
9. Review by the University Curriculum Committee (UCC).
10. UCC recommendations posted in the Curriculum Register.
11. Review by Academic Affairs Program Effectiveness Committee, when appropriate.
12. Approval by Vice President for Academic Affairs or designee.
13. Approval by President, when appropriate.
14. Approval by Off Campus Approval bodies, when appropriate.

## Moratorium for Proposals in Campuswide Sharing Stage:

There will be a 10 working day moratorium, starting from the publication date of the Curriculum Register, during which departments, deans, or individual faculty may raise objections or concerns, in writing, to the proposing School or College Curriculum Committee or Program Faculty for proposals in the campuswide sharing stage. The Campuswide Sharing section of the Curriculum Register contains only a summary of the curriculum proposal. Please ask the Department Curriculum Committee or Program Faculty for a complete proposal packet if you have questions or concerns.

## Moratorium Date: December 5, 2017

Once the moratorium date has passed for campuswide sharing and no objections are received, the proposal will continue through the stages of the curriculum review process.

Summary of Changes: The IDS Program proposes a new minor in Global Studies. Since IDS already has a major concentration in Global Studies and has built coursework around that concentration, it seems a logical evolution for the department and the campus. Global Studies is a relatively recently developed ADT for community colleges, and being able to pursue a minor in Global Studies will be an advantage for transfer as well as native students.

IDS conceives of this minor as one that will incorporate existing courses across departments and colleges. As IDS developed the minor, we contacted departments with courses that fit the profile of the minor. We considered lower division, mainly GE, courses as well as upper division courses that had no (or manageable) prerequisites, looking for coursework that would both relate and contribute to the Program Learning Outcomes we developed. The inclusion of other departments' syllabi, sent to IDS with the understanding that the courses would be included as electives in the minor, is tacit agreement. It speaks well of the project and of campus collegiality that all but one department contacted enthusiastically agreed to participate.

Summary of Changes: The Biology Depai1ment wishes to update its Programmatic Learning Outcomes for the BA and BS degrees. There was a considerable amount of redundancy in the old outcomes, and this led to difficulties in assessment. The proposed revisions reduce the number of outcomes by two, remove overlap among the outcomes, and update them to be more relevant to today's study of Biology.

Summary of Changes: To better prepare our students with the state-of-the-att technology for the workforce, Computer Science Department has developed two new courses: Discrete Structure and Software Development. These two courses are providing excellent opportunity for our students to better improve their programming skills. Based on our latest review of our curriculum and student performance, department has concluded that our students need more programming courses in order to become better prepare for this field. This goal is achieved by adding two new course that focuses on programming skills and reinforcing programming applications to some of the topics within the course. These two courses have been offered before under CSC 295; and have provided advanced programming skills for our students. There are about 20-25 students taking Software Development course, and another 20-25 students taking Discrete Structure course each semester. We propose to create pe1manent courses CSC281 Discrete Structure which may substitute for MA T28 l- Discrete Math (alternate required course) and CSC300 - Software Development which is currently an elective course. We believe, through these two courses, our students are better prepared for graduate studies and the workforce.

CSC 458: Network Security Theory Testing through Penetration
Type of Change: New Courses

Summary of Changes: To better prepare our students with the state-of-the-a1i technology for the workforce, Computer Science Department has developed two new courses: Enterprise System Security and Network Security through Penetration Testing. These two courses are providing excellent opp01iunity for our students to learn the cutting-edge technology in network security. These two courses have been offered before under CTC CTC495; and have provided considerable skills for our students in network and cyber security. There are about 20-25 students taking each courses per year. Enterprise System Security is offered during springs and Network Security through Penetration Testing is offered during fall. We have received positive feedback from students about these two courses. We propose to create permanent courses CTC456Enterprise System Security and CTC 458 -Network Security through Penetration Testing. We believe, through these two courses, our students are better equipped with the current technology and are better prepared for the workforce especially due to the constant and continuing changes in the field of security.
