#### **College of Arts and Humanities**

**Program/Course Name:** B.A. English: Language and Linguistics

**Proposer:** Iara Mantenuto

Type of Change: Program Modification

Summary of Change and Rationale: We are changing the name of the BA option from "English: Languages and Linguistics" to "Linguistics" in order to: (i) reflect the change in the program elevation that we are currently undergoing by which we will be dropping the "English:" in front of the title, and (ii) reflect a widely accepted trend in the field of linguistics and thus making our degree more transparent to students, graduate programs and people hiring our students one day.

**Program/Course Name:** Minor in English: Language and Linguistics

**Proposer:** Iara Mantenuto

**Type of Change:** Program Modification

Summary of Change and Rationale: We are changing the name of the minor from "English: Languages and Linguistics" to "Linguistics" in order to: (i) reflect the change in the program elevation that we are currently undergoing by which we will be dropping the "English:" in front of the title, in alignment with the BA title change as well, and (ii) reflect a widely accepted trend in the field of linguistics and thus making our degree more transparent to students, graduate programs and people hiring our students one day.

Program/Course Name: Certificate in English: Teaching of English as a Second Language

Summary of Change and Rationale: The proposed modification changes the title of the program from the "Certificate in English: Teaching of English as a Second Language (TESL)" to "Certificate in Teaching English to Speakers of Other Languages (TESOL)." The current "M.A. in English, TESL option" is being elevated to a stand-alone degree, to be titled "M.A. in Teaching English to Speakers of Other Languages." The proposed change will align the certificate with the affiliated M.A. program.

**Program/Course Name:** ART 100 Looking at Art

**Proposer:** Jim Keville

Type of Change: Course Modification

Course Description: ART 100. Looking At Art. (3 Units). Learning to perceive art through discussion of selected historical periods, development of a descriptive vocabulary, and observation of actual works of art. Introduction to theories of interpretation and evaluation. Offered Fall, Spring

Summary of Change and Rationale: ART 100 is an Area C1 General Education course. The Art and Design department has been successfully offering ART 100 as an online course since Fall 2016. We have been offering 3 – 5 sections of the online course each academic year in addition to the 4 face-to-face sections each year with robust enrollments.

It was not clear to the Art and Design Department that this course was not approved to be taught as an online course until recently. This is the reason for this course modification. When the pandemic began in Spring 2020 all courses were temporarily allowed to be scheduled online and now that we are returning to



pre-pandemic course scheduling and offerings, the fact that ART 100 has not been given final approval to be offered online has come to our attention.

Since we are making this request, we would also like to request this course be approved for hybrid delivery as well. This will allow more flexibility in future scheduling needs.

Successful and effective online courses at CSUDH continue to be needed to offset growing enrollments with limited classroom instruction space.

Program/Course Name: LBR 365 Racial Capitalism

**Proposer:** Alfredo Carlos **Type of Change:** New Course

**Course Description:** This course focuses on the ways in which race and racism have been central to the political economic development of the U.S., with a particular focus on understanding how they were used to develop capitalism and how it impacts workers in our society.

**Summary of Change and Rationale**: This new course will offer valuable perspectives on race, racialization and political economy to CSUDH students who are interested in learning about how intersections of race and class shape the economy, the workplace, and working-class communities. This proposed new course will enhance the breadth and depth of the Labor Studies Department's offerings.

Summary of Change and Rationale: We are proposing that THE315 be frozen because it has the same

title as HUM310 and we have been informed

by Academic Programs that only one course with this title can be active



### **College of Business Administration & Public Policy**

Program/Course Name: OMG 428 Purchasing Management

Proposer: G. Keong Leong

Type of Change: Course Modification

**Course Description:** Examines activities directed to securing the materials, supplies, equipment and services required for the proper and efficient functioning of a business, including related planning and

policy issues.

Summary of Change and Rationale: The course was taught online last spring and the students were able to learn well in that semester. Through weekly forums and instructor-led group activities, the online delivery of this course can ensure more than 45 lecture hours. PTE results from the past online course section of this course are highly positive. This is an important concentration course because of the demand for graduates in the purchasing area. All organizations including CSUDH have a purchasing function and taking this course will provide students with the necessary background knowledge to be successful in the purchasing profession. Information we get from the Institute of Supply Management is that there is a shortage of supply chain management graduates and in particular graduates with purchasing management knowledge. OMG 428 is required of all the students concentrating on Global Supply Chain Management, and it is designed to mostly apply basic concepts to real cases through mostly self-paced learning activities often in teamwork settings, and therefore it is completely suitable for online delivery.

Enrolment has gone up when the course was offered online previously. Increased enrollment will ensure a lively discussion board on Blackboard and make it easier to organize team projects. The course is offered once a year. Depriving the students an opportunity to take the class due to scheduling conflicts will not be in the best interest of all stakeholders.

**Course Description:** CHE 102. Chemistry for the Citizen. (3 Units). A non-mathematical treatment of the basic principles of chemistry and their application to various facets of life in a highly technological

society. Offered Fall, Spring, All terms

**Summary of Change and Rationale**: The proposed change is to now include in the title of the GE CHE102 course "Global Citizen", to cement the promotion of inclusiveness and welcomeness when a student searches for a GE Area B1 course.

Program/Course Name: CHE 103 Chemistry Lab for the Citizen

**Proposer:** Kenneth Rodriguez

Type of Change: Course Modification

**Course Description:** CHE 103. Chemistry Lab for the Citizen. (1 Units). Recommended general education course for students interested in the chemistry of everyday life. Includes determining the composition of foods and drugs, measurements, unit conversions, scientific notation, chemical representations, mole concept, structure of atoms and molecules. Three hours of laboratory per week. Offered Fall, Spring

**Summary of Change and Rationale**: The proposed change is to now include in the title of the GE CHE103 course "Global Citizen", to cement the promotion of inclusiveness and welcomeness when a student searches for a GE Area B3 course.

Program/Course Name: MAT 327 Introduction to Machine Learning with Software

**Proposer:** Matt Jones

Type of Change: Course Modification

Course Description: Machine learning uses methods and concepts to sift through data to create automated prediction and decision programs. This course will develop the underlying mathematical concepts and proficiency with R or similar software to understand, build, and apply machine learning. Summary of Change and Rationale: Mat 327 is one of the newest classes added to the math department's offerings. It is perhaps the most computationally intensive course among our offerings. The proposed change will allow for more flexibility in how the math department offers this class, so as to include online format as well as the usual face-to-face.

Online formats for this course have been offered for the two and a half spring semesters since the Covid-19 period began, and over this period, the instructor's methods and effectiveness for offering this course online have improved significantly. In fact, for this course, with all the different media that is used, the online format works more effectively than giving a face-to-face class in a computer lab classroom. One big advantage of the online format is that the instructor can have several screens displaying simultaneously (and all the students can see everything much more clearly on their own screens) and so giving explanations of difficult concepts that require comparing several displays can be done much more effectively. Additionally, according to surveys given to the students on what works best for their learning, a significant portion of students appreciated the convenience and effectiveness of online instruction and would take such courses in the future.

For this class, most all of students prefer the online format and can learn better from it. The instructor also feels that for this class, the online format is a superior one. Program/Course Name: MA in English: Teaching of English as a Second Language

**Proposer:** Iara Mantenuto

Type of Change: Program Modification

Summary of Change and Rationale: We are changing the name of the MA option from "English: Teaching of English as a Second Language (TESL)" to "Teaching English to Speakers of Other Languages (TESOL)" in order to: (i) reflect the change in the program elevation that we are currently undergoing by which we will be dropping the "English:" in front of the title, and (ii) be more inclusive of both English as a Second Language learners and also English as a Foreign Language Learners, something that is possible by adding the "Other" to the title, hence reflecting a widely accepted trend in the field of TESOL.

**Program/Course Name:** Master of Science in Business Analytics

Type of Change: New Program

Summary of Change and Rationale: CBAPP is moving towards the development of Specialized Masters' Programs, Master of Science in Business Analytics is a graduate degree program that enables students to develop in-depth skills and knowledge in applied data analytics, data mining and business intelligence, organizational decision making, and quantitative analysis. The program allows students to apply analytics foundations and skills to a specific domain area to meet the increasing market demand for expertise in data analytics. With mastery of the analytics skills, knowledge, and abilities developed in the specialized domain, graduates will successfully enter the professional workplace capable of identifying, analyzing, and solving analytics problems for better business intelligence and decision support in organizations.

This program is designed to meet the increasing demand of organizations for graduates with cutting-edge knowledge and expertise in transforming big data into managerial and strategic assets. It's an emerging, interdisciplinary field that draws upon fundamental principles of management information systems, statistics, business and public administration. Students will perform in-depth analyses of information systems issues and advanced data analytics concepts and techniques that can be applied to a variety of business and public administration domains. Program/Course Name: MA in Education – Curriculum & Instruction (option); Dual Language

Learning (option); Transitional Kindergarten (option)

**Proposer:** Edward R. Curammeng

Type of Change: Program Modification

Summary of Change and Rationale: The MA in Education has recently proposed four (4) new courses. The Program Modifications proposed continues on that momentum to specify where those new courses will exist within the MA's options (Curriculum & Instruction; Dual Language Learning (option); Transitional Kindergarten). Specifically, we propose: 1) changing total units from 31 to 30, 2) removing a one-unit course that covered a comprehensive exam; 3) move two previous core courses to electives; and 4) move an elective to a core course. All modifications align strongly with the updated COE Vision and Mission, MA programmatic goals and learning objectives.
