Campus-Wide Proposal Sharing for Undergraduate Proposals

The following course and program proposals have been submitted for review to their department curriculum committee and program faculty.

College of Arts and Humanities

Program/Course Name: AMS 300 Searching for America

Proposer: Anne Soon Choi

Type of Change: New Course

Course Description: This course introduces student to current theories in American Studies research and public practices. The course focuses on key concepts, theories objects of analysis, and current research in American Studies.

Summary of Change and Rationale: We are elevating American Studies into a stand-alone major. This course is a required course within the major and serves as the introduction to the major for transfer students.

Program/Course Name: AMS 302 American Appetites

Proposer: Annemarie Perez

Type of Change: Course Modification

Course Description: This course is a study of food from an American Studies interdisciplinary approach. Topics include but not limited to the relationship of food to: Immigration, imperialism, gender, modernity, racial/ethnic identity, place, liberation and class.

Summary of Change and Rationale: This course is a study of food from an American Studies interdisciplinary approach. Topics include but not limited to the relationship of food to: immigration, imperialism, gender, modernity, racial/ethnic identity, place, liberation, and class. This course modification request is part of the reorganizing the IDS curriculum in response to our recent program review. It changes one of the subtopics of the IDS 336 course into its own course with a distinct number.

Program/Course Name: AMS 304 Comics and Graphic Novels

Proposer: Annemarie Perez

Type of Change: Course Modification

Course Description: This interdisciplinary course on comics and graphic novels examines how comics/graphic novels combine the visual and the textual with movement and discusses the ways this makes it distinct from other literary and visual forms.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum response to our recent program review. It changes one of the subtopics of the IDS 336 course into its own course with a distinct number. The American Studies concentration in IDS is being evaluated into a stand-alone major. This course will also be used in the American Studies major.

Program/Course Name: AMS 330 Documenting America

Proposer: Vivian Price

Type of Change: Course Modification

Course Description: From early visual text to contemporary digital media, people have used images to capture social change in America. This course will explore how these events were documented in the media and by ordinary people and analyze their meanings.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. It changes one of the IDS 326- Social Documentation into its own course with a distinct number and a new course title. This course modification is also part of a larger program modification to elevate American Studies, a current IDS concentration into a stand-alone major. AMS 330 is a major course.

Program/Course Name: AMS 331 American Religious Movement

Proposer: Anne Soon Choi

Type of Change: New Course

Course Description: Examines the variety of ways of being religious in the North American context, asking such questions as what role religion played in the shaping of our diverse culture, and how geography, politics, and culture transformed the beliefs of American people.

Summary of Change and Rationale: This is a new course on the cultural and social impact of American Religious Movements; the course will be part of the new major in American Studies and is a major course.

Program/Course Name: IDS 316 LA Detectives

Proposer: Anne Marie Perez

Type of Change: Course Modification

Course Description: An examination of crime stories in Los Angeles across fiction, non-fiction, and film, especially the LA noir tradition. Particular attention is paid to gender, race, and class, and their accompanying discourses and how crime stories mediate these discourses.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS in response to our recent program review. It changes one of the subtopics of the IDS 330 course into its own course with a distinct number.

Program/Course Name: IDS 317 Race and Popular Culture

Proposer: Anne Soon Choi

Type of Change: Course Modification

Course Description: From an Interdisciplinary perspective, this class will examine the intersections of race and popular culture. By doing so, this course will explore how popular culture is central to negotiating racial meaning in American society.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. We are converting all our topics course to stand-alone courses assigned a specific course number. This will streamline the advising process for faculty and college advisors and simplify degree roadmaps for students. IDS would like to have the option to offer IDS 317 as an online and/or hybrid course. As an upper division degree completion program for working adults, the IDS major requires online and hybrid courses.

Program/Course Name: IDS 324 Consumerism in the US

Proposer: Anne Soon Choi

Type of Change: Course Modification

Course Description: This course examines the key issues that are tied to American consumerism including advertising, class, identity, globalization, the impact on the environment. Additionally, this course will pay close attention to how race, gender and class intersects with consumerism.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. We are converting our topic courses to stand alone courses assigned a specific number. This will streamline the advising process for faculty and college advisor and simplify degree roadmaps for students. IDS 324: Consumerism in the US is a new title. It has been taught as “American Consumerism” as an online and/or hybrid course. As an upper division degree completion program for working adults in IDS major requires online and hybrid courses.

Program/Course Name: IDS 327 Work in Contemporary America

Proposer: Anne Soon Choi

Type of Change: Course Modification

Course Description: Since WWII we have witnessed a transformation in how we understand work. This course examines how technology, immigration, globalization and the Covid 19- Pandemic have radically restructures labor markets in the United States and around the world.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. We are converting all our topic courses to stand alone courses assigned a specific course number. This will streamline the advising process for faculty and college advisors and simplify degree roadmaps for students. IDS would like to have the option to offer upper division degree completion program for working adults. The IDS major requires online and hybrid courses.

Program/Course Name: IDS 328 California Experience.

Proposer: Anne Soon Choi

Type of Change: Course Modification

Course Description: This course examines the national and global significance of California. By doing so, students will explore the history and culture expression of the state as a way to understand the larger story of diversity, national belonging, and social justice in America.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. We are converting all our topic courses to stand alone courses assigned a specific course number. This will streamline the advising process for faculty and college advisors and simplify degree roadmaps for students. California Experience has been taught as a subtopic of IDS 326 since 2010. IDS would like to have the option to offer IDS 328 as an online and/or hybrid course. As an upper division degree completion program for working adults, the IDS Major requires online and hybrid courses.

Program/Course Name: IDS 352 Epidemics

Proposer: Anne Soon Choi

Type of Change: Course Modification

Course Description: Examines the history and sociological importance of epidemics and pandemics in charting global development, social and class conflict and genocide. Conventional disease contagion such as Covid 19 is explored in addition to abstract transmission such as mental illness, drug addiction, and violence.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. We are converting all our topic courses to stand-alone courses, assigned a specific course number. This will streamline the advising process for faculty and college advisors and simplify degree roadmaps for students. IDS would like to have the option to offer IDS 352 as an online and/or hybrid course. As an upper division degree completion program for working adults, the IDS major requires online and hybrid courses.

Program/Course Name: IDS 355 Chasing Dinosaurs

Proposer: Anne Soon Choi

Type of Change: Course Modification

Course Description: From the first fossil discovery to modern popular culture, the human fascination with dinosaurs has influenced the nature of the way we understand science and discovery. Using an interdisciplinary lens, this course investigates how these long extinct creatures continue to shape our world.

Summary of Change and Rationale: This course modification request is part of reorganizing the IDS curriculum in response to our recent program review. We are converting all our topic courses to stand-alone courses, assigned a specific number. This will streamline the advising process for faculty and college advisors and simplify degree roadmaps for students. IDS would like to have the option to offer IDS 355 as an online and/or hybrid course. As an upper division degree completion program for working adults, the IDS major requires online and hybrid courses.

Program/Course Name: HUM 308 Garden of Delights

Proposer: Lorna Fitzsimmons

Type of Change: Course Modification

Course Description: We will examine the garden and the pastoral impulse as it operates in our cultural psyches. All the participants of the garden are fair game for interrogation; let's try to forge some new tools for analyzing them.

Summary of Change and Rationale: This course is being modified to online format in order to enhance student access to the course. Students need the flexibility of online delivery. The course title and number are being changed because the generic HUM 310, of which this course was a subtitle, is no longer being offered. Accordingly, the generic course description is being removed, and specific course description is being shortened to align with the current expectations for the length of course descriptions. The course is being integrated into the proposed Health Humanities for People and Planet Earth Minor. It provides an option for meeting part of the proposed minor requirements.

Garden of Delight

We will examine the garden and the pastoral impulse as it operated in our cultural psyches. All the participants of the garden are fair game for interrogation; let's try to forge some new tools for analyzing them.

Program/Course Name: HUM 311 Power of Myth

Proposer: Lorna Fitzsimmons

Type of Change: Course Modification

Course Description: Generic description for HUM 310, of which this course is a subtitle: Prerequisite: HUM 200 or equivalent. Analysis of a major concept in humanistic thought and expression, e.g. the individual and society, success and failure in the U.S., death and dying, war and society, global popular music, Etc. Repeatable with different topics for credit. [Original description for this HUM 310 subtitle Power of Myth is unknown. Tracey Haney searched for this to no avail. The original paperwork for this course is unknown.]

Summary of Change and Rationale: This course is being modified to online format in order to enhance students' access to the course. Students need the flexibility of online delivery. The course title and number are being changed because the generic HUM 310, of which this course was a subtitle, is no longer offered. Accordingly, the generic course description is being removed, and the special course description is being shortened to align with current expectations for the length of course descriptions. The course is being integrated into the proposed Health Humanities for People and Planet Earth minor. It provides an option for meeting part of the proposed minor requirements.

Power of Myth

Myth is the underpinning for all ancient civilization, reflecting humanity's search for meaning and answers to life's most important questions: what does it mean to be human? What is the meaning of life and death?

Program/Course Name: SPA 352 Central American Cultures

Proposer: Cynthia Villanueva

Type of Change: Course Modification

Course Description: Students study cultural, socio-political, racial, and historical characteristics of Central American countries. There is an emphasis on the analysis of culture via the study of Indigenous, Afro-Latin, and women's literary and artistic production.

Summary of Change and Rationale: While our university and our department offer many classes that address the Latin American experience overall (SPA 151, SPA 351, SPA 456) and the Mexican and Mexican American experience in depth (SPA 461), we feel there is a need to address and understand the culture and specific issues that our Central American community is facing. This course will attempt to better understand and represent this neglected important part of our campus community. Our students will be able describe the ways in which the U.S. immigration policies are expanding the physical and political militarization of the border, most specifically at the Mexico-Central American borders by investigating the geopolitical and transnational migration factors of Central American migration and its diaspora. They will also identify key historical events that marked the initial stages of violent conflict in Central America, and their connection to U.S. relations in the region. They will explain the destructive impact on economic, social, and governmental institutions in Central America because of civil wars by discussing the role of gender and race as subjects of multilayered oppression in Central American society and politics and compare political, cultural, gendered, and socio-economic discourses that are contextualized in literature, art, and film.

The Modern Languages Department within the Spanish Program is developing a new series of Spanish Minors, and this new course is part of the curriculum in order to meet Program demands for our Major and proposed new Minors. This course will also serve a co-curricular need for a multidisciplinary proposed Spanish minor with the Social Sciences program.

Program/Course Name: Spanish Grammar and Writing, Minor

Proposer: Michael Galant

Type of Change: Program Modification

Summary of Change and Rationale: We wish to remove SPA311 (Structure of Spanish) as a required class for this option since we have concluded that this course is not essential for achieving the Program Learning Outcomes for this minor.

The above also means reducing the number of units in the minor from 15 to 12, which will make the minor more accessible to students.

Program/Course Name: Spanish Linguistic, Minor

Proposer: Michael Galant

Type of Change: Program Modification

Summary of Change and Rationale: We propose removal of courses that are essentially prerequisite courses: SPA 280 Grammar for Spanish Composition, SPA 305 Advanced Composition, Syntax and Stylistics I, SPA 311 Structure of Spanish. We also propose that SPA450 History of Spanish become required for all students in the minor, rather than only being required for students who are taking SPA311 towards completion of the Spanish BA (in either option) and therefore are unable to use SPA311 towards completion of the minor.

This minor is mostly designed for students completing a BA in Spanish. Under the current BA, these courses are all included in the common core, and most of the students completing this minor are also completing the Spanish BA in the Spanish Literature option.

We are separately proposing an overhaul of the Spanish BA, in which we propose a) replacing the Literature option and the Linguistics option in the Spanish BA with a combined Literature and Linguistics option (students can take a mix of linguistics and literature courses) and b) creating a new option within the BA, Spanish for the Professions. In the new BA, the common core will still include SPA280, SPA305, and SPA311, so students in either of the two new Spanish BA options can still complete the minor in Spanish Linguistics - we do propose that students continue to be able to complete this minor and the BA (either of the two new options) in Spanish. However, for students completing the proposed new Literature and Linguistics option, the Spanish Linguistics minor will probably appeal most to students taking primarily literature courses, since students will not be able to double count linguistics courses towards both the revised Spanish Linguistics minor and the revised Spanish BA.

Program/Course Name: Spanish Literature, Minor

Proposer: Michael Galant

Type of Change: Program Modification

Summary of Change and Rationale: We propose removal of courses that are essentially prerequisite courses: SPA 280 Grammar for Spanish Composition, SPA 305 Advanced Composition, Syntax and Stylistics I, SPA 330 Interpreting Hispanic Literature. We also propose that SPA454 Cervantes: Don Quijote become required for all students in the minor, rather than only being required for students who are taking SPA330 towards completion of the Spanish BA (in either option) and are therefore currently unable to count that course towards the minor.

This minor is mostly designed for students completing a BA in Spanish. Under the current BA, these courses are all included in the common core, and most of the students completing this minor are also completing the Spanish BA in the Spanish Linguistics option.

We are separately proposing an overhaul of the Spanish BA, in which we propose a) replacing the Literature option and the Linguistics option in the Spanish BA with a combined Literature and Linguistics option (students can take a mix of linguistics and literature courses) and b) creating a new option within the BA, Spanish for the Professions. In the new BA, the common core will still include SPA280, SPA305, and SPA330, so students in either of the two new Spanish BA options can still complete the minor in Spanish Linguistics - we do propose that students continue to be able to complete this minor and the BA (either of the two new options) in Spanish. However, for students completing the proposed new Literature and Linguistics option, the Spanish Literature minor will probably appeal most to students taking primarily linguistics courses, since students will not be able to double count literature courses towards both the revised Spanish Linguistics minor and the revised Spanish BA.

Program/Course Name: KOR: Korean

Proposer: Benito Gomez

Type of Change: New Subject Prefix

Summary of Change and Rationale: We currently are using MLG as a temporary prefix. We can only use it for two years and the class will be offered again after their first successful year. Also, it would be easier for the students interested in Korean to find the class under the KOR (Korean) prefix.

College of Business Administration & Public Policy

Program/Course Name: BUS 445 International Business

Proposer: Sherine El Hag

Type of Change: Course Modification

Course Description: Focused study in international business with an emphasis on the additional risks, uncertainties and difficulties of business conducted across national boundaries; students will use disciplinary writing to produce case studies and written reports to analyze and examine the financial, management, legal accounting and marketing areas. A grade of C or better in this course fulfills the GWAR requirement for Business Majors and Minors.

Summary of Change and Rationale: The current proposal doesn't change the course content, but the course modifications ensures a new assessment approach focusing on the ability of the students to apply , and analyze the course materials in a written format This can help the students have a deeper understanding of the course materials and apply it to the real life. how to translate their learning into a written narrative to be more engaged (i.e. via written discussions, papers). Written assignments and projects can help the students organize their thoughts, clarify their ideas, develop coherent arguments, retain, and apply the course materials. According to different studies, students retain the information more when they write, rather than just read, or hear.

Writing can enhance the students' critical thinking, analytical, and communication skills. The proposed course modification can help the students to improve their writing skills, retain the course materials, and gain a better grasp of international business and its various applications.

College of Education

Program/Course Name: EDU 470 Individual Learning Plan Development

Proposer: Kate Esposito

Type of Change: Course Modification

Course Description: Induction candidates gain the knowledge and skills to develop a professional individualized Learning Plan that focuses on improving teacher performance via inquiry and formative assessment of their teaching practice to improve student learning.

Summary of Change and Rationale: This course is part of the Induction Program and has been successfully offered in an online format for the past two semesters. This class is well suited for an online format. Further several of our sister campuses offer the Induction Program online, as such as we anticipate an increase in enrollment in the Induction Program.

Program/Course Name: EDU 474 Individual Learning Plan Completion

Proposer: Kate Esposito

Type of Change: Course Modification

Course Description: is required. Induction candidates complete a professional Individualized Induction Plan that focuses on teacher performance via inquiry and includes a comparison of formative and summative assessment of their teaching practice to improve student learning.

Summary of Change and Rationale: Change mode online and hybrid teaching modality to SPE 474.

This class has successfully piloted in a hybrid format. Most of the CSU's offering an Induction Program offer classes online or hybrid format. This change in modality will enable CSUDH to "grow" the program.

Program/Course Name: LBS 203 Introduction to Teaching: Becoming a Transformative Educator

Proposer: Jen Stacy

Type of Change: Course Modification

Course Description: Students will critically consider the historical and philosophical foundations of education by analyzing the purposes, structures, and functions of schools whilst centering the intersectional standpoints of various placed-at risk groups. Students will develop the knowledge and dispositions to empower themselves as reflective, creative, and transformative educators (3 units).

Summary of Change and Rationale: LBS 203 was last modified in 2016 as a component of a larger curriculum redesign of the Liberal Studies Major. At that time, LBS 203 was renamed to LBS 203: Introduction to Education: Becoming a Transformative Educator. Since that time, changes have taken place in the College of Education writ large and within the LBS major and courses that have affected the role that LBS 203 plays in the major's curriculum and have pointed to the need to fine tune the focus of the course in the following ways.

First, the College of Education has updated its vision and mission statement to indicate its critical perspective on teacher preparation. Currently the LBS 203 course upholds a dominant perspective of the history of schooling and teaching in the United States. The degree to which students are introduced to a critical perspective and the depth with which they contemplate how schools serve marginalized groups of people varies depending on the instructor. To uphold our College's vision and mission, as well as to best prepare pre-service teachers to teach in the greater Los Angeles area, it is essential that all LBS students learn about the history of education through a critical lens. Modifying the course content so that it explicitly requires this perspective will allow for this.

Currently, not all students are equally prepared to enter LBS 370, a 5-unit upper-division course, from this angle and, as such, may struggle more with the content and assignments in LBS 370. The modifications to LBS 203 will ensure that all students are prepared with these foundational understandings early in the LBS major so that they can deepen their knowledge about pedagogies for change when they take the next course in the sequence.
