- b. Bill DeLuca- The program and course modification proposals will revamp the Theatre Arts and Dance Programs by redesigning the THE 346 course. The modification will simplify the program, making it more efficient so students only have to take the course one time for 3 units.
- c. S. Pawar- With the program modification (UCC 11-12-031) to eliminate the minor requirement for the major, the BA in Theatre Dance option will be out of compliance with the Star Act. Students need 40 upper division units to graduate.
 - i. Students will need to be advised/notified that they need to take an extra 9 units.
- d. J. Keville- Questioned if wording could be included in the catalog so students are aware of this requirement.
- e. C. Tubbs- Independent studies will be set up for current students in the program to substitute for 1 unit.
