4. New Business- Curriculum Proposals

a. UCC 12-13 045 LAW 340- Online MC: Charles Thomas

- i. This is an existing course; want to offer it fully online. Also wants to offer an on-campus LAW 340; consider a Hybrid in the future based on a study of the students. Wants to offer online course in the summer. Course is an elective course for several options in the BUS major.
- ii. Midterm and final online via Blackboard. Utilize discussion forums for course readings monitored by instructor. Uses every means of randomized questions; strict time limits; can only see one at a time; students can't answer next until one is answered.

- iii. E. Magruder- suggested we standardize campus initiatives based on the CO's quality online teaching initiatives.
 - 1. K. Bragg- a revised version of the teaching initiatives are used for Cal State Online. May want to forward this to Senate to put this in place. She'll send to C. Thomas and UCC; it is a great resource for online teaching.
- iv. Programs will not exceed their 50% with the approval of this course to online. Will make a note about that.
- v. K. Bragg- There could be a potential for liability or administrative issues or research problems if students can drop in and out of on-campus section. Make sure they are only students registered for the course.
 - 1. C. Thomas- Will take out Hybrid aspect.
- vi. C. Jacobs- Learning Outcomes are measurable.
- vii. J. Davis moved to approve. D. Sherman seconded. M/S/P

- viii. L. Stallworth- minor typo- F grade points 64-69.

b. UCC 12-13 001 AFS 205 NC: Salim Faraji

- i. Course was approved for GE with minor revisions; submitted for GE to be used as Lower Division GE requirement in Africana Studies introducing students to the political, social and cultural movement. A Hip Hop minor is also being introduced through the Music department; this is the basic course. HUM 310 will be introduced soon also. Department hopes to launch course this fall.
- ii. J. Davis- topic has been a field of study for almost 20 years in other institutions, even ivy league.

 1. Proposed hybrid courses are 1/3 online to 2/3 face to face.
