 - i. STAR Act is mentioned in the justification. Course does not apply to the STAR Act.
 - b. C. Jacobs- DSS Statement- currently states to “contact me.” That statement needs to be taken out. Revise statement to include university DSS contact information; suggest including phone number and email/website only since office location changes.

a. M. Beheshti- Course has been taught as a 495 course for 2 years. Department wants to make it a standard/new course. Course is taught by volunteer instructors, at no new cost to university.

b. C. Jacobs- SLOs- Course has 30 SLO's- This is too many; each outcome needs to be assessed. Recommendation to collapse into 5-10 SLO's.

i. 5-10 SLO's is recommended number for courses.

c. DSS Statement- Needs to be revised; include the contact information to the office, phone and email/website. Remove statement to contact the instructor.

d. J. Davis- SLO's #2- "fundamental of C # program..." asked if "#" was a typo.

i. M. Beheshti- "C Sharp" is the name of a computer program; not a typo.

e. C. Blackaller moved to approve pending revised DSS statement and SLO's. J. Gasco seconded. M/S/P

a. T. Haney- FYI- A program modification is not required. Electives are not indicated in the Political Science program description.

b. K. Bragg- There's a similar course in Public Administration on terrorism. Asked if Public Administration had any comments on this course; if they support this proposal.

c. J. Davis – Asked what the difference is or need the need for this new course since a similar course is offered by Public Administration.

- i. H. Salhi- The theme is the same but the focus of this course is different. This new course focus is on the act of terror. PUB/Criminal Justice (CJA) course looks at terror as a crime. This course has been taught as Special Topics for 2 years. Sees the course as important to the Political Science department.
- d. C. Jacobs- The SLO's are OK.
- e. J. Han- Grading scale- no plus or minus.
 - i. H. Salhi- This is intentional, not a typo. Did not want grading to be that detailed with +/- grade. It can be changed.
- f. C. Bordinaro- The Computer Information Literacy Statement is missing. Needs to be added. This has become a syllabus requirement since course was originally proposed.
- g. C. Bordinaro moved to approve pending addition of Computer Information Literacy Statement. D. Hoopes seconded. M/S/P
 - i. Approved Pending

8. UCC 12-13 146 SOC 500 NC- K. Pinto

- a. It is not indicated on the proposal how the course is going to be used in the program.
- b. L. Stallworth- course classification C-13. Guidelines are 2hrs/unit. Course should be 6 hours per week. It is only 2.5 /wk. Need to reclassify course as a lecture.
- c. K. Pinto- Departments wants to offer the course to new graduate students to introduce them to the graduate program. Propose students take the course early to help them learn about resources on campus, help them graduate sooner, learn about career options in the field.
- d. C. Jacobs- Mode of instruction question C-13. Recommend to classify as C-2 lecture.
 - i. K. Pinto- Wants students to get 3 units. Will change to C2- lecture; it's not a seminar course.

- e. T. Haney- Grading- Course is A-F. It's listed as an A-B/NC on the proposal form. She will change/correct form.
- f. K. Pinto- Wants to offer course as an elective.
 - i. Does not require a program modification.
- g. K. Pinto- Course was developed because of the problems she's seen with students as graduate coordinator.
- h. C. Jacobs- Syllabus needs SLO's; there are course objectives only.
- i. C. Bordinaro- Computer Info Literacy Statement - Need to add standard information to "Computing Needs" statement.
- j. J. Davis-DSS Statement- Include contact information- Phone and email/website.
- k. T. Haney- Department needs to complete the program template for online/hybrid course offerings.
- l. C. Bordinaro moved to approve pending Student Learning Outcomes, revised Computer Info Literacy Statement and DSS Statement. D. Hoopes seconded. M/S/P

1. UCC 12-13 068 COM 100- online MC

- a. Item G refers to course being used for Cal State Online. There is no way to police that. T. Haney- This is handled by the scheduler; they will have to manually correct that for CSONline sections of the course. Will have to 'go on faith' that the scheduler will cap enrollment at 50.
- b. It's a C-1- large lecture intended for Applied Studies CSONline students.
- c. Concerns about large number of students.
 - i. Decided to lower cap to 30 based on UCC's recommendation.

 - b. Course uses a “collaboration feature.” Asks students for availability; creates groups, a schedule and testing based on availability.
 - c. Instructor received online teaching certification in 2008 from a certification course through University of Texas Pan American.
 - d. A research paper is not required for this course.
 - e. T. Haney- This shouldn’t be a 495 “topic” course. New course need a “real” number. She will work with department to find an available new course number for this course.
 - f. J. Davis moved to approve. C. Bordinaro seconded. M/S/P
 - i. Approved
3. L. Stallworth- Asked a general question about the difficulty in filling out the template. It does not indicate how far to go back with the information. How difficult is it to obtain the piloted course information?
- i. T. Haney- There has not been any reported issues; schedulers and department chairs complete the template.

Business Administration (120 Unit Requirement) - Myron Sheu

- a. Proposed to retire BUS 300 and break up into 3 new courses- BUS 301, BUS 302 and BUS 303. The course content does not change. The format changes for the 120 unit requirement, but the content will not change.
- b. M. Maki- All Business majors are 121 units. This modification will change the core and reduce the program by 1 unit so they will be in compliance.
