

To Apply to the Counseling Program:

1. Apply through <u>Cal State Apply</u>. <u>The Cal State Apply application is the only application needed to apply to the Counseling program.</u>

The School and College Counseling program admits students Fall semesters only.

Application opens in Cal State Apply on October 1.

We offer two application deadlines: Priority deadline is December 1 Regular deadline is February 1

The *Priority* deadline (Dec. 1) offers applicants first consideration for application review over those received by the Regular deadline and also provides an earlier decision notification (mid-March). It does not offer a less competitive review, the review criteria and process are the same for both deadlines. In order to receive priority review, applications must be submitted in full in Cal State Apply by Dec. 1 and official transcripts must be received by the Admissions Office before Feb. 1. Current undergraduates should send official transcripts after Fall term grades are posted, but before Feb. 1.

The *Regular* deadline (Feb. 1) provides a review for applications that are submitted in full in Cal State Apply and have official transcripts received by Admissions by the Feb. 1 deadline. Applications submitted by the Regular deadline will be considered for remaining spaces in the cohort. All complete applications will be reviewed, regardless of the number of priority applications accepted. Decision notifications are expected to be sent by late-April.

- 2. Please refer to the application instructions below as well as on our <u>website</u>. The MS Counseling Program Information the Frequently Asked Questions sheets posted on our website can be helpful to prospective students when applying.
- 3. Applications must be completed in full by either the **Priority deadline of Dec. 1** of the **Regular deadline of Feb. 1** in order to be considered for admission, so be sure to upload all requested documents and respond to each question carefully.

Counseling Program Application Procedures and Process

1. Apply:

Complete CSUDH MS Counseling Program Application at <u>Cal State Apply</u>. The University application requires a \$70 non-refundable application fee.

2. Official transcripts and Bachelor's degree:

Submit official transcripts directly from all institutions where you enrolled in any undergraduate coursework (and post-graduate if applicable), with the exception of transcripts from CSUDH, which are not needed.

Transcripts should be sent to the CSUDH Office of Admissions & Records at admissions@csudh.edu

CSUDH will accept electronic transcripts via the following services:

If your institution provides certified electronic transcripts through another service, please have those transcripts sent directly from your institution to admissions@csudh.edu

Within the Cal State Apply application, you will also upload <u>unofficial</u> transcripts of all coursework.

Your bachelor's degree must be from a regionally accredited university and *posted no later* than the Spring term prior to Fall admission. All undergraduate majors are welcome to apply and there are no prerequisite courses required for admission.

3. Letters of Recommendation:

Please include the names and emails of three professionals who can evaluate your potential for graduate study as a counselor. Appropriate references include professors and supervisors/employers who have served in a supervisory capacity with you (as opposed to personal sources such as family, friends, colleagues, or clergy). Your referrers will then be contacted directly by the Liaison-CSU Apply system to request letters of recommendation on your behalf.

To give your referrers sufficient time to submit your letters, be sure to submit your letter request well in advance of the deadline. The CSU Apply application portal will close on the Feb. 1 deadline, after which time letters will not be able to be accepted.

Letters must be written specifically for the Counseling program within one year prior to the application deadline. Please note that letters that refer to another graduate program, are older than one year, or are not provided by those in the requested referrer positions will not be considered. For this reason, it is recommended that your referrers do not use the "reuse" letter feature within Cal State Apply.

4. Statement of Purpose (4-5 page minimum):

Your statement should include: 1) a description of personal experiences that have contributed to your decision to become a counselor; 2) both personal strengths and areas you have identified for growth; 3) your perception of the role of a school or college counselor; and 4) a critical issue in counseling that you plan to research as a

student and eventually integrate in your future counseling work. Please use headers specifying each section, and double space your statement using 12-point font.

5. Minimum 3.0 Grade Point Average:

A *minimum* of a 3.0 grade point average for ALL undergraduate and graduate coursework is required. If you do NOT meet this requirement, then it is strongly recommended that you provide verification of a minimum combined score of 300 on the Verbal and Quantitative Tests of the Graduate Record Examination (GRE - Revised).

6. Fingerprint Clearance Requirement

All applicants must privide evidence of either a Certificate of Clearance, a Valid California teaching credential, or a Current Substitute Teaching Permit. For information on how to obtain a Certificate of Clearance go to the CTC website: Fingerprint Information and the COE Directions for Applying for a Clearance

Livescan forms are available from the COE Student Services Center or online from CTC.

In your application, please upload a copy of **one** of the options below:

- Certificate of Clearance
- Valid Teaching Credential or Substitute Teaching Permit
- Receipt of Certificate of Clearance Application (to show it is in process)

If you have not yet *applied* for the Certificate of Clearance, your application will be considered incomplete.

The California Education Code §44340 & §44341 require that all individuals receive fingerprint clearance from the California Department of Justice (DOJ) and the Federal Bureau of Investigation (FBI) through the Commission. This must be met as a condition of admission.

7. Tuberculosis (TB) Clearance:

All applicants must submit verification of a current TB clearance. TB clearances are valid for 4 years.

8. Basic Skills Requirement (BSR): For MS School Counseling/PPS applicants only Applicants admitted to the School Counseling option or PPS credential must demonstrate meeting the CA Basic Skills Requirement (BSR) prior to beginning coursework. Please go to CTC's website for options on how to meet this requirement. Methods include approved undergraduate coursework, a combination of coursework and CBEST sections, as well as target scores on SAT, ACT, or AP tests. If you plan to meet the BSR through coursework, we will evaluate this after admission. Please do not include coursework evaluation forms in your application.

9. Personal Group Interview:

All complete applications will be given careful consideration by the admissions committee. From there, a final round of applicants will be selected to participate in

small group interviews. Applicants selected for interviews will be contacted at least a week in advance of the interview date, to be held in March via Zoom. Invited applicants are expected to attend the interview_as it is a required component of the admissions application.

Objective of Study requirements:

- 1) The MS degree offers two specialization options: *School* Counseling and *College* Counseling. Due to university degree requirements, <u>only one option can be selected for the degree</u>. However, students will have the opportunity to gain experience in both levels during the program.
- 2) Candidates interested in pursuing the PPS credential only without pursuing the MS degree, <u>must</u> already possess a Master's or Doctorate degree in Counseling, Education, Psychology, or Social Work (other fields are not acceptable for substitution). For application purposes, you must apply to the MS degree as there is not a PPS only option in Cal State Apply. If you are admitted and decide to not earn the MS, a faculty advisor can assist you in modifying your plan.
 - If you have a previously related Master's degree and are considering earning the PPS credential only, it may be in your best interests to obtain a 2nd Master's degree. It is recommended that you apply under a MS degree option and then consult with an advisor upon program admission to determine your best course of study.
- 3) The College Counseling Certificate is only available to MS School Counseling students and PPS credential-only students. Students pursuing the MS College Counseling option cannot also pursue the Certificate due to the prominence of the degree in relation to the certificate. The College Counseling Certificate can be added to School Counseling students' plan of study after admission.
