- 1. Apply at Cal State Apply (\$70 non-refundable application fee). For more info click here.
- 2. All official academic transcripts must be submitted from all undergraduate and any postgraduate work. Submit one set of official sealed transcripts directly to:

CSUDH Office of Admissions & Records, 1000 E. Victoria St., Carson, CA 90747.

Note: CSUDH students/alums do not need to submit CSUDH transcripts.

- 3. Cal State Apply Statement of Intent The Cal State Apply (University) application may ask you for a Statement of Intent. When prompted for your statement on Cal State Apply, write in the textbox "Statement sent to Program".
- 4. Cal State Apply Supporting Documents The Cal State Apply (University) application will ask you add documents such as Basic Skills Requirements; click "I Am Not Adding Any Documents" when prompted.

Note: Cal State Apply Application must be completed before completing the Teacher Education Advanced Degree application. Once you have completed the Cal State Apply application, you will receive a CSUDH Student ID number (usually within 7 - 10 working days). Your Student ID number is necessary for you to complete the Program application.

- 1. **Teacher Education Advanced Degree Application:** Apply at CSUDH COE here. You will submit a Curriculum Vitae (CV).
 - a. Click on Apply Now
 - b. Under *Programs*, select *Teacher Education Advanced Degree/Credential Programs*



- c. Click Apply.
- d. Be sure to include the Letter of Intent for Dual Language Learning Certificate!

The following documents must be uploaded to complete the program application:

- 2. **Official Transcripts:** All official academic transcripts must be submitted from all undergraduate and any post-graduate work. Copies of originals issued by the college or university will be accepted only if the college or university logo or seal appear on the copies. Web printouts will not be accepted. *Note:* CSUDH students/alums do not need to submit CSUDH transcripts.
- 3. **TED Minimum 2.75 Grade Point Average (GPA):** A minimum of 2.75 GPA in the last 60 units of upper division course work attempted. If you do NOT meet this requirement, then you will need to submit a TED Petition Low GPA (Grade Point Average).
- 4. **Two (2) Letters of Recommendation:** Select **two (2)** recommenders who can provide a realistic appraisal of your qualifications for graduate-level coursework. The recommender will be sent an electronic Letter of Recommendation form to complete. You will not be able to view this recommendation.
- 5. **Statement of Intent**: ¿Qué significan los programas de doble inmersión para ti o para la comunidad en dónde trabajas? (Escribe por los menos dos páginas.)
- 6. **Verification of Valid Initial Credential:** Valid initial credential (e.g., California Level I or Preliminary).





Upon completing the **Cal Apply and Teacher Education Advanced Degree** applications, allow 4 - 6 weeks for your application to be processed. For questions/status regarding your program application contact the COE Admission Unit at (310) 243-3530. You will receive an email of your conditional admission into the Teacher Education Division.

The MA in Education: Dual Language Learning Option will require completion of 31 units with a minimum 2.75 grade point average. The Graduate Record Examination (GRE) is not required for applicants. A minimum of 21 semester units must be completed in residence. A maximum of nine (9) units of coursework taken previously may be used to meet the course content requirements of a graduate program if they have been completed within the seven years immediately preceding the completion of the requirements for the degree.

No courses may apply toward the required number of units of approved graduate work that have been used to meet the requirements of another degree.

NOTE: You must successful complete the Graduate Writing Assessment Requirement (GWAR or equivalent) prior to completion of 9 units.

Teacher Education Appeal/Exceptions Policy

Students may file a petition for exception to some TED requirements or regulations (including requirements for initial COE program admission, admission to phases, and out-of- date coursework) by filing a "TED Petition for Exception." Petitions are reviewed by the TED Chair, with faculty consultation. Petitions are available in the department office.

Note: For some requirements such as basic skills, certificate of clearance, and intern eligibility, there are no exceptions per CTC regulations and CSU EO 1077.
