| <b>Requirement:</b> To be eligible to borrow a Federal Direct Loan, you must be enrolled at least half-time (6 units undergraduate/Teaching Credential/Certificate/2 <sup>nd</sup> Bachelors and 4 units [500 level] graduate). |
| There are two types of loans you may be offered:  |

- **SUBSIDIZED**: The Federal government will pay the interest on your loan while you are enrolled for at least a <u>half-time</u> unit load.
- **UNSUBSIDIZED:** The borrower is responsible for the interest accrued on this loan. You may choose to defer the interest while in-school, but the interest will be capitalized (i.e. added to the principal) when you go into repayment.

**Note:** You will be assessed an origination fee for each disbursement of your loan. These charges do not reduce the amount you are required to repay.
