

# 2020-21 Employee Reporting Guide Sexual Misconduct, Dating/Domestic Violence, and Stalking

If a colleague or student notifies you about recent or past sexual assault, incident related to dating/domestic violence, or stalking, please follow the steps below to provide a supportive response and fulfill your responsible employee reporting requirements under CSU EO 1095.

### When should I notify the Title IX Office?

- A colleague tells you that they're experiencing unwanted sexual advances in your workplace
- A student reports that they're experiencing domestic violence at home
- A coworker says that have PTSD from a past sexual assault
- If you're unsure give the Title IX Office a call and ask!



#### How should I respond to a disclosure?

- 1. "Are you <u>safe</u> right now?" Determine if there is an imminent threat of future harm. If there is a threat, call the CSUDH Police Department by dialing ext. 3333 or 911.
- 2. "Thank you for telling me about this." Thank them for confiding in you, support their decisions, and empathize with their experience.
- 3. "Here are some <u>resources</u> available to you." Let them know about the resources and options available to them or help them access the <u>csudh.edu/gei</u> for a full list.
- 4. "As an employee at CSUDH, I'm required to notify the Title IX Office about what you've shared with me. After I notify them, they'll reach out and provide you with information about your resources and options. You can choose whether you'd like to meet with the Title IX Office or not." Fulfill your responsible employee reporting requirements by notifying the Title IX Office when you find out about sexual misconduct, dating/domestic violence, and stalking by filling out the online form at <a href="mailto:csudh.edu/gei/make-report">csudh.edu/gei/make-report</a> or calling (310) 243-1025. In response, someone form the Title IX Office will reach out via phone or email to consult with you about our next steps and provide resources and options.

## How should you notify the Title IX Office about a disclosure?

You can notify the Title IX Office however you are comfortable doing so – you even may schedule a meeting to talk about your options before providing identifying information.
