AVAILABILITY, LOCATION, AND METHODS TO SUMMON LAW ENFORCEMENT ASSISTANCE

Availability and Location of Law Enforcement Assistance

The California State University Dominguez Hills (CSUDH) University Policy Department (UPD) is located at 1000 E. Victoria Street, Welch Hall B-100, Carson, CA 90747 and provides police services 24 hours a day. UPD dispatch can be reached directly 24 hours a day from any campus phone at 911 or from cellular phones at (310)-243-3333.

Enforcement and Arrest Authority

The California State University, Dominguez Hills Police Department employs twenty-one (21) highly trained, full-time, sworn police officers six (6) 911 Dispatchers for the 24-hour protection of the campus community. The peace officers of this department have state- wide police authority and jurisdiction per Penal Code 830.2 and Education Code 89560, and are vested with law enforcement powers and responsibilities, identical to the local police or sheriff departments in your community.

Crime Reporting

The University Police are responsible for service, law enforcement and maintenance of order on the university campus. The entire campus community is strongly encouraged to report all known or suspected incidents of criminal activity on campus to the University Police Department as soon as possible. Voluntary confidential reporting of crime incidents on-campus may be made to other non-police campus security authorities, who are officials of the institution and have significant responsibility for student and campus activities (including but not limited to: student housing, student discipline, campus judicial proceedings, athletic officials, deans, or faculty advisors). Confidential crime reporting can be made when the victim of the crime elects or is unable to make such a report.

To Report a Crime

- Give your name, telephone number, and location.
- Give clear and accurate information.
- Be prepared to supply suspect and vehicle description, and direction of travel.
- DO NOT HANG UP! Follow the instructions of the dispatcher.
- Students residing in on-campus housing may also report crimes to the on-duty Resident Advisor who will ensure the immediate notification of the University Police.

SPECIAL SAFEGUARDS FOR FACILITIES OR ACTIVITIES

Security of and Access to Campus Facilities

All campus facilities are key-accessed, and most are open daily for scheduled campus community use. The

Housing and Residential Life Complex is gated with key access only. Campus key control and distribution is a function of Facilities Services. To provide for the security of campus facilities, the University Police enforces Educational Code 89031:

The trustees may establish rules and regulations for the government and maintenance of the buildings and grounds of the California State University. Every person who violates or attempts to violate the rules and regulations is guilty of a misdemeanor.

Campus facility access may be revoked per Penal Code 626 (Trespass).

Security Considerations Used in Maintenance of Campus Facilities

The University Police are responsible for security of all campus facilities. Personnel perform building lockup as needed and monitor maintenance issues including campus lighting, door locks and general environmental safety in conjunction with Facilities Services. Regular inspections and surveys of campus indoor/outdoor lighting, shrubbery and walkways are conducted. The University participates in crime prevention through environmental design concepts for planning and improvements on campus.

Special Event Safety Planning

Preparation for large events on campus involve the creation of Incident Action Plans according to the Standardized Emergency Management System and in collaboration with mutual aid agencies and contracted safety personnel.

New Student Orientation

University Police personnel provide personal safety tips and emergency contact information to new students on a regular basis. Students are informed of policies, crime reporting procedures, and safety programs.

New Employee Orientation

Throughout the year University Police personnel present safety policies and procedures to new employees, in cooperation with the Human Resources department. Employees are informed of injury and illness prevention, emergency preparedness, safety programs, and crime reporting procedures.

ACTIONS IN THE LAST 18 MONTHS TO INCREASE SAFETY

- 1. Additional rooftop speaker (mass notification) on new student residential building.
- 2. Filled the vacant campus Emergency Manger position.
- 3. Developed and posted a COVID-19 Campus Response & Safety Plan.
- 4. Created a "Toros Together" webpage containing updated information and resources.
- 5. Modified work and classroom areas to provide for social distancing.
- 6. Upgraded the Computer Aided Dispatch system to "RIMS."
- 7. Victim's Advocate initiated Center for Advocacy, Prevention, and Empowerment (CAPE).
- 8. Campus participation in Denim Day, anti-sexual assault campaign.
- 9. Campus participation in the "Great American Shakeout" drill.
- 10. Participated in "Take Back the Night" safety walk with LA County Sheriffs and Carson Community.
- 11. Provided Title IX and Sexual Assault training to numerous campus groups.
- 12. Incorporated "Text-to-911" into University Dispatch system.
- 13. University Police appointed Department Operations Specialist.

CHANGES IN SAFETY PRECAUTIONS DURING THE NEXT 24 MONTHS

- 1. All campus exterior lighting will be upgraded.
- 2. Re-instate Community Service Officers (CSO) program under supervision of UPD.
- 3. Re-instate Safety Escort program under supervision of UPD.
- 4. Provided Rape Aggression Defense Training (RAD).
- 5. To safely repopulate campus, develop a Plan that includes; social distancing, distribution of PPE, testing, and vaccination.
- 6. Provide Green Dot (bystander intervention) training to campus. Title IX, CAPE, and Police collaboration.
- 7. Campus Safety and Emergency Preparedness presentations open to entire campus.

RECORDS OF ON-CAMPUS CRIME

California Education Code 67380(a)(1)(A)

California State University campuses are required by California Education Code 67380(a)(1)(A) to compile records of all occurrences reported to campus police, campus security personnel, or campus safety authorities of, and arrests for, crimes that are committed on campus and that involve violence, hate violence, theft, destruction of property, illegal drugs, or alcohol intoxication, and to make this information available within two business days if requested by students, prospective students, employees, or the media.
