Hello Toro Students!

As University support services and classes continue to take place via alternative and virtual delivery, the Office of Community Standards would like to remind all CSUDH students of your responsibility to maintain and uphold our campus community values as stated in the <u>Student Conduct Code Title 5</u>, Article 2, Section 41301.

The University is committed to maintaining a safe and healthy living and learning environment for students, faculty, and staff. Each member of the campus community should choose behaviors that contribute toward this end. Students are expected to be good citizens and to engage in responsible behaviors that reflect well upon their university, to be civil to one another and to others in the campus community, and contribute positively to student and university life.

Although you may not have on-campus interaction with faculty, staff, and other students during this time, in our virtual community you are still expected to engage in a respectful manner that promotes a high regard for academic integrity, professionalism and overall good community membership. Even in this remote state of operating, if the Student Code of Conduct is violated in any way, The Office of Community Standards will address these issues accordingly as outlined in Executive Order 1098.

For courses that are approved to meet on campus the following protocol is in place for the safety of our campus community.

Face coverings

The campus will make cloth masks available for any student or employee that requests one. Students in need of a face covering can request one through their instructor. Instructors can take a count of how many students would like to be provided a mask and send an email to Work Control to request face coverings. Neck gaiters and bandanas are not acceptable forms of face coverings.

Bathroom protocol

All campus bathrooms will be gendered single use only. The gender inclusive bathrooms in the Library and Science & Innovation buildings will remain gender un-assigned and single use. Signs will be posted at all bathrooms with the expectation that students and employees will self-monitor for compliance.

Building/room ingress and egress

There will be posted signage on which doors to use as entrances and exits to buildings and rooms as well as direction of travel where appropriate. Students should abide by the signage as they come and go.

No loitering or lingering on campus

Students are only permitted to come to campus to attend their face to face class and must depart campus once the class has concluded. They may not mix with groups from other classes or enter other buildings.

Custodial Service

Facilities Services will provide regular custodial service to classrooms which includes cleaning and disinfecting surfaces. For rooms with more than one class a day, Facilities will need at least one hour in between the classes to clean the space. Faculty and students are encourage to wipe down any equipment that is used during the class. Equipment or items should not be shared or passed around during the class.

Disruption, failure to abide by safety protocols

Disruptive students will be referred to the Office of Community Standards and consequences include probation and possible suspension. If there is concern of an imminent threat to the health and safety of any occupant of the room, University Police should be contacted. A class session may be cancelled if continuing the class would further escalate a situation.

Thank you for doing your part in upholding the University's student standards as we all navigate this new virtual learning environment for the semester.
